AGREEMENT**

**ACCEPTANCE:** With respect to the equipment specified herein, this agreement contains the entire agreement of the parties hereto and supersedes any contract or agreement of prior date between the undersigned Renter and the Company and is subject to final acceptance by the Company. Renter acknowledges receipt of a copy of this agreement and agrees that acceptance by the Company will be shown by its invoice.

**Highlights of Rental Agreement:**

1. I understand that the equipment I am renting is to be returned to Desert Pines Equine Center within 2 calendar days of the expiration date of my rental term as selected above. \_\_\_\_\_(initials)
2. I understand that if equipment is not returned within 2 calendar days of the rental term expiration, automatic extensions of 2 weeks at a rate of \$300.00 will be charged to my account. \_\_\_\_\_(initials) (see "Automatic Extension" below for details)

**PAYMENT:** All rentals are payable in advance, beginning on the effective date of delivery, by credit card, check or cash. A credit card must be put on file.

**EXTENSION OF RENTAL TERM:** Renter may opt to extend the rental term. Renter MUST notify Desert Pines Equine Center to extend the rental term. A separate rental extension order will be placed with the corresponding payment applied. Rental extensions maybe verbally requested and confirmed.

**AUTOMATIC EXTENSION:** The equipment is due back within 2 calendar days of end of the rental term. An automatic extension of 2 weeks at the rate of \$300.00 will be applied to customer's credit card if the equipment is not returned within the 2 days. The extension will begin the day after the prior rental period expired. Automatic extensions will be applied at two-week intervals until customer returns the system to Desert Pines Equine Center.

**PROVISIONS AS TO USE:** This agreement is intended by the parties as an agreement to rent and not to sell, conditionally or otherwise. The equipment rented is and shall remain the property of Desert Pines Equine Center, and Renter shall have no right, title, or interest therein.

**DURATION OF AGREEMENT:** This agreement shall remain in force from the date of delivery and initial billing until entire system is returned to Desert Pines Equine Center. The Renter will deliver the above equipment to Desert Pines Equine Center in good condition, except for normal wear and tear. Any pieces of the equipment not returned will be charged to Renter at the then published retail price.
